Through Video consultations / Telehealth doctor sessions, this clinic has the ability to work for patients throughout Australia where the patient's regular Doctor's referral & current health summary are mandatory. In Australia, a registered doctor can access Medicinal Cannabis through special access scheme (SAS) with an application to the Therapeutic Goods Administration (TGA).

In Australia online GP consultations on Medicinal cannabis treatment is not Medicare funded (No Medicare rebate available) & also currently only few doctors are spending their time & also have expertise & experience in this special field of medicine.

# Medicinal Cannabis or Home Grown/Black Market Cannabis???

You cannot legally produce your own cannabis for medicinal use. Home- grown medicinal cannabis/Black market cannabis products have unknown concentrations of active ingredients and contain potentially harmful contaminants and these home- grown products are easily diverted into the illicit drug market.

Medicinal cannabis products need to be consistent, contaminant free and high quality so doctors can make safe prescribing and dosage decisions.

## Cannabis plants & Cannabinoids:

Cannabinoids are naturally occurring compounds found in the Cannabis Sativa plant. Of over 480 different compounds present in the plant, only around 66 are termed cannabinoids. The cannabinoids are most abundant in the female flower head, which is used in the manufacture of medicinal cannabis products.

The most well- known among these compounds is THC, which is the main psychoactive ingredient in cannabis. CBD (Cannabidiol) is another very effective cannabinoids in cannabis which is with NON psychoactive effect but can be very useful to treat multiple medical conditions specially for Chronic Pain, Epilepsy, MS, Stress-Anxiety/depression, Cancer pain, Nausea vomiting etc.

## **Know about CBD & THC:**

Among around 66 cannabinoids -The main cannabinoids in cannabis are Cannabidiol (CBD) and delta-9 Tetrahydrocannabinol (THC). THC is the compound found in street or black market Cannabis which has been cultivated for recreational purposes. Black market cannabis is unlikely to contain other

Cannabinoids that may be more beneficial for treating your conditions or symptoms. THC is a psycho-active compound and will elicit a psycho-active response, making you feel high.

CBD and THC (both Cannabinoids) are listed on the Controlled Drug Register in Australia, meaning that they cannot be legally sold direct to the public. Products with less than 0.01% of any Cannabinoids can be sold direct to the public in Australia, but 0.01% is not a therapeutic dose

### What's nice in CBD?

CBD (Cannabidiol) is a compound that can be extracted from Cannabis plants that have been cultivated to contain large amounts of CBD by regulated manufacturing processes to ensure the integrity of the product.`

CBD is completely non-psychotropic or non-psycho-active. It will not make you feel high or intoxicated in any way. Benefits of CBD is still under research however till now researchers found CBD may give a range of potential with its following properties:

### **B. COST OF MEDICINAL CANNABIS (Your Medicine Cost)**

<u>Medicinal cannabis is not on the Pharmaceutical Benefits Scheme (PBS)</u> so, patients need to pay the costs of purchasing the product. <u>There is currently no government subsidy for the cost of medicinal cannabis for individual treatment</u>, and the government does not regulate the prices for supply of approved products. Some

patients have been refunded the cost of the medicine on their health fund. Please check with your health fund. The cost of medicine depends on -

- the cannabinoids in the product- CBD,THC etc.
- the amount required by the patient How many drops/capsules you need,
- the source, shipping expenses, customs fees Whole seller cost
- the dispensing fees charged by the dispensing pharmacy.- Usually \$10-\$20 more than Whole seller cost

Our general estimate for an average chronic pain patient is to spend \$5 to \$15 per day on Medicinal Cannabis.

## Daily dose vs Cost??? - Let's calculate...

Please note: There are multiple Medicinal cannabis products legally available under TGA approval from which our doctor will select & prescribe most effective & less costly product based on your medical condition.

There are different strength/ Sized bottle of CBD Oils legally available in Australia. To understand dose, this is just an example: In a 10ml bottle of CBD oil the total amount

of CBD is 2400mg or in other words, that 10ml bottle holds 200 drops of CBD oil. 1 drop=12 mg of CBD On an average, patients with chronic pain need 4-10 drops each day (it totally depend on individual circumstances & medical condition

Cost for that 10ml bottle is around **\$275- \$300.** This 10ml bottle lasts **usually 20-35 days** (it totally depend on individual circumstances again).

There are few other cannabis products available in Australia like CBD Lozenges, CBD Capsules, CBD:THC blend, THC dominant oils etc. Our doctor may choose from them after discussion with you however CBD Oil is most popular choice to start with due to its safety & cost effectiveness.

# How long it may take to receive Medicinal Cannabis from chemist?

You can expect a copy of TGA Approval letter & a Script within 7 days from the Doctors video consultation day. Give these two to your Chemist who will order that from the whole-seller.
Usually within 3-5 working days Chemist gets your medication through post.

Please Note- for every month, chemist needs to order & needs this 3-5 days time as in Australia, usually no Chemist can keep medicinal cannabis product in their stock without TGA Approval & proper script.

# Will CBD/Medicinal Cannabis work for your medical condition?

The simple answer will be, "We don't know". Effect & mechanism of action of Medicinal Cannabis/ CBD is still under research, however many patients are getting life-changing positive effect. On the other hand, some are getting limited or even NO effect.

If you want to give a try, form our side, we will be supporting you with accessing, guiding & close monitoring of medication effects. It totally depends on how your body endocannabinoid system react with CBD or medicinal cannabis compounds. Its individualized. So, it's really a difficult question.
